Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Richmond Local Municipality to amend the existing contract:

Description: AMENDMENT TO THE EXISTING APPOINTMENT OF FLEET AFRICA AND FOR THE AWARDED TENDER NUMBER 09/2022/2023 FOR THE LEASE/HIRE OF MOTOR VEHICLES WITH COMPLETE MAINTENANCE TO RICHMOND LOCAL MUNICIPALITY.

Reasons for the proposed amendment: The municipality will be entering into a new project which the municipality has never experienced before, and therefore lot of investigations had to be done towards the project which took the municipality longer than it had envisaged. The appointed scope could not be finalised within the appointment term of the contract period.
