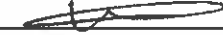

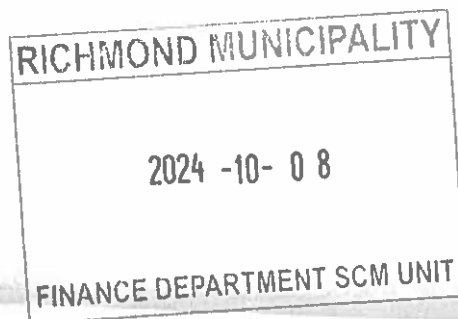

4. SPECIFICATION

The South African National Standard for the Application of the National Building Regulations Part T states clearly that portable fire extinguishers installed in a building shall comply with the requirements in SANS 1910, and shall be installed, maintained and serviced by competent persons in accordance with SANS 1475-1 and SANS 10105-1. Such portable fire extinguishers shall bear a certification mark from an accredited certification body.

- 4.1 Examine the extinguisher for any signs of tampering, ensuring the tamper seal isn't broken.
- 4.2 Take a pressure and gauge reading and make sure it is within safe operating limits.
- 4.3 Removing the discharge hose to check for blockages or corrosion
- 4.4 Weigh and clean the extinguishers
- 4.5 Ensure wall mountings are secure
- 4.6 Inspect the condition of the extinguisher and repair any obvious damage, leakage or corrosion.
- 4.7 Make sure the operating instructions are facing outwards and can be easily read.
- 4.8 The appointed service provider shall prepare and submit a report after a visit in which the information on the date of testing and servicing, the defects noticed, actions required to be taken to set right the defects and the action have been taken must be reflected in the report.

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20	or	90/10

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
