NOTICE IN TERMS OF SECTION 116(3) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 (ACT 56 OF 2003) FOR THE AMENDMENT TO THE EXISTING APPOINTMENT OF GRAP AND MSCOA COMPLIANT FIXED ASSET REGISTER (FAR) FOR A PERIOD OF THREE (3) YEARS TENDER NO KZN_RLM_15/2021/2022

Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Richmond Local Municipality to amend the existing contract:

Description: **AMENDMENT TO THE EXISTING APPOINTMENT OF GRAP AND MSCOA COMPLIANT FIXED ASSET REGISTER (FAR) FOR A PERIOD OF THREE (3) YEARS TENDER NO KZN_RLM_15/2021/2022**

Reasons for the proposed amendment: While the department is actively capacitating its internal staff to take over the asset register function the verification of infrastructure asset presents a unique challenge that requires specialized knowledge and experience. The complexities involved in assessing, classifying and valuing infrastructure asset-such as roads demand expertise beyond.

The current appointed service providers have established a valuable relationship with the affected parties which is an integral part of this specific process. It is in the best interest for the Municipality to proceed with the current service provider(s) to complete the above-mentioned projects.

It is therefore practical and or cost effective for the Richmond Municipality to extend the existing contract of GRAP AND MSCOA Compliant Fixed Asset Register (FAR) for a Period of Three (3) Years to Richmond Local Municipality on a reduced scope until the contract is completed.
