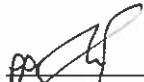

Repairs and maintenance of faulty traffic light at the intersection of Chilly Street and Nelson Street in Richmond

1. Supply and Install type UA Automotor traffic Signal Controller
2. Supply and Install 4 x Traffic Signal Heads
3. Megger intersection and replace cables as necessary
4. Inspect and replace poles termination tops as necessary
5. All poles to be primed and Painted
6. Ensure that the intersection is fully operational and compliant.

The bidders shall be responsible for removal and reinstatement of all paving and/or sidewalk. the traffic signal controller must be guaranteed for a period of 24 Months (twenty-four months), from the date of installation and the traffic signal LED modules being guaranteed for a period of 24 months (twenty-four months) from the date of installation.

The bidders must be authorized to affect timing changes and have the necessary spares on hand to honor the guarantee timeously. 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
