The Municipality invites suitably qualified and experienced service providers to **supply, install, test, and commission LED lighting fixtures** at various municipal facilities, including Main Offices, MM Offices, Library, LED Offices, Works yard, and Testing Ground. The project includes both **new installations and the replacement of existing lighting infrastructure**.

2. SCOPE OF WORK

The scope of work includes, but is not limited to:

- Supply of specified LED lighting fixtures
- Installation, mounting, wiring, and connection to existing electrical systems
- Replacement of existing light where applicable
- Testing and commissioning of all installed lights
- Removal and safe disposal of redundant fittings
- Compliance with applicable electrical and safety standards

CERTIFICATE OF INDEPENDENT BID DETERMINATION
