A) Portion of Left Hip End Of Roof

- Strip roof tiles, ridge caps, remove warped batons and roof underlay
- Supply and install new batons include for aligning/levelling batons and installing storm clips
- Supply and install new roof underlay sisalation
- Replace all damaged concrete roof tiles include for setting and levelling tiles.
- Apply creosote to new exposed batons
- Install damp proofing below ridging, waterproof mortar to be used to set ridge caps and all joints to be waterproofed

B) Main Office Roof

- Replace all damaged tiles and ridges
- Remove existing waterproofing from ridge tiles and apply new waterproofing

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
